Stop worrying about the after-school gap! Kinetic Kids provides a safe, high-energy, and educational environment for your children, starting the moment the school bell rings.

What We Offer:

- Stress-Free Transportation: We pick your children up directly from school and bring them to our facility.
- Snacks: Upon arrival, kids enjoy a snack provided by Leaps & Bounds (included) or can purchase one of their choice from the cafe.
- Active Play: From arrival until 4:00 PM, children engage in supervised active games to burn off energy.
- Diverse Activities: Starting at 4:00 PM, children rotate into their specialized groups for fitness, art, games, and character-building workshops.
- Homework Support: Need to check "homework" off your to-do list? We offer a focused, small-group homework session from 4:00 PM to 4:45 PM.

Criteria for Acceptance

We accept students of any race, color, nationality, or ethnic origin.

In order to register for Kinetic Kids, you will need:

- A signed registration form (paper)
- A signed Payment Option form
- A Master Info Form
- Parental Consent Notice
- Payment of the Annual Kinetic Kids Supply Fee

There is a **Non-refundable** registration fee of \$85 per 9 month term per child.

There are two payment options for Kinetic Kids.

Option 1: Pay Monthly by the 1st with cash, check or credit card.

Option 2: Pay weekly with credit/debit card or EFT on file.

Your account will be assessed a \$25 late fee for any accounts not paid by the 1st for monthly payments or for any credit card that is declined on Friday for weekly payments. EFT transfers and credit cards will be run on the Friday before the week begins. A \$35 NSF charge will be added to your account for all returned checks, and/or returned echecks.

Safety & Pickup Policies

Approval Only

Children will only be released to individuals listed on your authorized pickup form.

ID Required: Any person not recognized as the "regular" pickup provider must present a valid Photo ID/Driver's License before a child is released. No exceptions.

Check-Out Procedures

To ensure a smooth transition, all parents are required to:

Park in the back parking lot near the pool. (Please do not park in the handicap spot)

Walk inside the facility to physically sign your child(ren) out for the day.

Closing Time & Late Fees

Our program is licensed to operate until 6:00 PM.

Prompt Pickup: All students must be picked up by 6:00 PM.

Late Fees: Arrivals after 6:00 PM will incur a strictly enforced fee of \$5.00 per minute, per child.

Policy Enforcement: Reliable childcare depends on timely pickups; families who are late three times will be asked to find alternative arrangements.

IMPORTANT: Attendance & Billing Policies

1. If Your Child is Staying Home...

To ensure every child is accounted for, we require a phone call by 2:00 PM if your child will not be attending that day.

- Why? Our drivers depart at 2:00 PM. Searching for a child who isn't at school delays our pickups at every other location.
- The Policy: Failure to notify us by 2:00 PM will result in a \$7.00 "No-Call" fee assessed to your account.

2. Vacation & Holiday Billing

We are proud to offer one of the most flexible billing policies in the area!

- Weekly Tuition: Regular weekly payment is required regardless of attendance to hold your spot. We do not prorate for individual missed days.
- Holiday Savings: Unlike most programs, if your school is out for an entire week (such as Christmas or Easter break), you are NOT charged for after-school care!
- Holiday Camps: These are separate events. If you wish for your child to attend, please sign up online or at Customer Service. Payment will be due the week before.
- The "Big Savings" Perk: You essentially get 25 vacation days throughout the school year where you don't pay for care you aren't using!

3. Leaving the Kinetic Kids Program

We hate to see you go, but if you need to leave the Kinetic Kids program, please follow these steps to ensure your account is closed correctly:

- Written Notice: A formal Drop Notice must be filled out and submitted.
- Two-Week Notice: We require a two-week paid notice prior to withdrawal.
- Final Billing: From the date your notice is submitted, two full weeks of payment are required. These must be paid in full before your child is officially dropped from our roster

Emergency Procedures

Your child's safety is our priority. In the event of an emergency:

Immediate Contact: Parents will be contacted immediately.

Medical Care: If a parent or emergency contact cannot be reached, we will transport the child to the nearest emergency room or urgent care center to ensure they receive immediate medical attention.

Weather & Safety Closures

We follow the guidance of the Livingston Parish School Board for all weather-related decisions, as they have the most direct access to emergency information.

Closure Policy: If the news reports that Livingston Parish Schools are closed or closing early due to dangerous weather (such as hurricanes, tornadoes, or floods), Kinetic Kids will also close early or remain closed.

Stay Informed: Please monitor local news stations like WAFB Channel 9 or WBRZ Channel 2 for official school closure announcements. This is the most reliable way to know if our program is operating.

Early Pickup: In severe weather scenarios, we will contact parents to pick up their children as soon as possible for everyone's safety.

"Mother Nature" Billing Policy

Ongoing Fees: Weekly tuition fees remain ongoing and due even if the facility must close for emergency conditions or dangerous roads as deemed by the Parish.

Discipline Policy

Positive discipline techniques will be utilized when necessary. These techniques include:

- Speaking with a child if their behavior is inappropriate for the area or material that they are using.
- Using positive language with the children to give praise for appropriate behavior
- After using the above techniques, if a child is having a problem cooperating in an area of the room, he/she is asked to go to another area of the room for a short while.
- If a child has a problem with appropriate behaviors, the child will be placed in a supervised "time-out" for one minute per year of age of the child. The teacher will then guide the child to think of a better way to interact with the other children, materials, etc...
- If a child is having consistent difficulties, he/she is asked to sit in the other room with a teacher so that he/she can think in a quieter atmosphere.
- If a child is having consistent difficulties, he/she will not be allowed to play during part or all of recess or schedule activity.
- Children with consistent difficulties are taken through the above procedures and the parents are regularly counseled on their behavior.
- No child or group of children shall be allowed to discipline another child.
- No child shall be deprived of snacks or any part of snacks for disciplinary reasons.
- Corporal punishment will not be utilized.
- If a child or parent is determined to be too disruptive to the learning environment, parents will be asked to find another program.

Illness Policy

Parents are asked not to send their children if they are ill. No medication of any type, including aspirin, will be administered unless a parent signs an authorization form at the front desk. All medication must be in a labeled RX bottle. Over the counter meds have to be labeled as well and reason for medication must be specific.

Parents are required to pick-up children if they exhibit any of the following symptoms:

Vomiting Diarrhea Fever
Unexplained rash Pink eye Lice

Children absent with a contagious disease are asked to bring a release form from a physician when returning and must be free of symptoms for 24 hours.

Transportation From School

Leaps & Bounds provides transportation from school to the Leaps & Bounds facility. Some schools drop off at Leaps & Bounds. Please check with the front office for a list of these schools. If your child is riding a school bus to Leaps & Bounds, you must arrange this through the school.

- All transportation arrangements conform to state laws including seat belts and child restraints.
- All children must stay seated and buckled until van comes to a complete stop at Leaps & Bounds. Please discuss this with your child.
- There will be a cell phone in every van.
- Children are under the direct supervision of Leaps & Bounds staff at all times. The driver or attendant shall not leave the children unattended in the vehicle at any time while transporting the children.
- Designated staff person shall be present when the child is delivered at Leaps & Bounds.
- The van shall be maintained in good repair.
- The use of tobacco in any form, alcohol, and possession of firearms in the van is prohibited.
- The number of persons in the van shall not exceed the manufacturers recommended capacity.
- The driver shall check the van to the completion of each trip to ensure that no child is left in the vehicle and all children were picked up and dropped off at the correct location.
- Leaps & Bounds does not provide for or arrange transportation to or from home.

Concession Accounts

Concession Accounts are available for your convenience. You can put money into their account and they can spend some each day in the concession area. The children like to call it their “bank account”! We have a log that keeps their ongoing balance for each day. You are more than welcome to set restrictions if you feel it necessary (Example: \$1.50 per day, no cokes, etc.). This is totally OPTIONAL.

Classes

You get a 20% discount on all other classes, with the exception of swim when you are registered in Kinetic Kids. At Leaps & Bounds, you only pay full price for one tuition. We offer many classes that happen in the time frame of Kinetic Kids such as gymnastics, tumbling, Ninja and cheerleading.

Holiday Camps

Leaps & Bounds will have camp when the students are out of school. These camps are also open to the public.

- The annual registration fee of \$85 per child is Non-refundable.
- I understand that Kinetic Kids is a school season program. Once enrolled, my child(ren) will be enrolled and billed until the end of the school year unless I notify Leaps & Bounds otherwise. I will still be billed even if school is closed due to weather. If I need to drop, I must turn in a written 2 week drop notice. From the date of the notice, 2 weeks of full payment are required.
- Payment is made by credit or debit card. Leaps & Bounds uses a web based program for billing. Credit card numbers are not stored at Leaps & Bounds if you register electronically. We accept Visa, Master Card, Discover or American Express.
- Tuition will be drafted on the Friday before the week happens, or on the 1st of the month if I am paying monthly. If my card expires or any account information is changed it is my responsibility to update the information. I can update information on-line or with our front office staff.
- I understand that Gymnastics, Cheerleading, Dance, Tumbling and Acrobatics are year round activities. Once enrolled, my child(ren) will be enrolled in class and billed until I notify Leaps & Bounds otherwise. Tuition will be drafted on the 25th of the month.
- I will be charged a \$35 NSF Charge for any returned echeck or check.
- Any account not paid on Friday, will receive a \$25 late fee.
- I must call the front desk if my child will not need to be picked up. A \$7 fee will be charged to my account if I fail to do so.
- I must pick up my child by 6:00 pm. I will be charged \$ 5 a minute per child after 6:00.
